About this report

The PRI Reporting Framework is a key step in the journey towards building a common language and industry standard for reporting responsible investment (RI) activities. This RI Transparency Report is one of the key outputs of this Framework. Its primary objective is to enable signatory transparency on RI activities and facilitate dialogue between investors and their clients, beneficiaries and other stakeholders. A copy of this report will be publicly disclosed for all reporting signatories on the [PRI website](#), ensuring accountability of the PRI Initiative and its signatories.

This report is an export of the individual Signatory organisation's response to the PRI during the 2020 reporting cycle. It includes their responses to mandatory indicators, as well as responses to voluntary indicators the signatory has agreed to make public. The information is presented exactly as it was reported. Where an indicator offers a response option that is multiple-choice, all options that were available to the signatory to select are presented in this report. Presenting the information exactly as reported is a result of signatory feedback which suggested the PRI not summarise the information. As a result, the reports can be extensive. However, to help easily locate information, there is a **Principles index** which highlights where the information can be found and summarises the indicators that signatories complete and disclose.

Understanding the Principles Index

The Principles Index summarises the response status for the individual indicators and modules and shows how these relate to the six [Principles for Responsible Investment](#). It can be used by stakeholders as an 'at-a-glance' summary of reported information and to identify particular themes or areas of interest.

Indicators can refer to one or more Principles. Some indicators are not specific to any Principle. These are highlighted in the 'General' column. When multiple Principles are covered across numerous indicators, in order to avoid repetition, only the main Principle covered is highlighted.

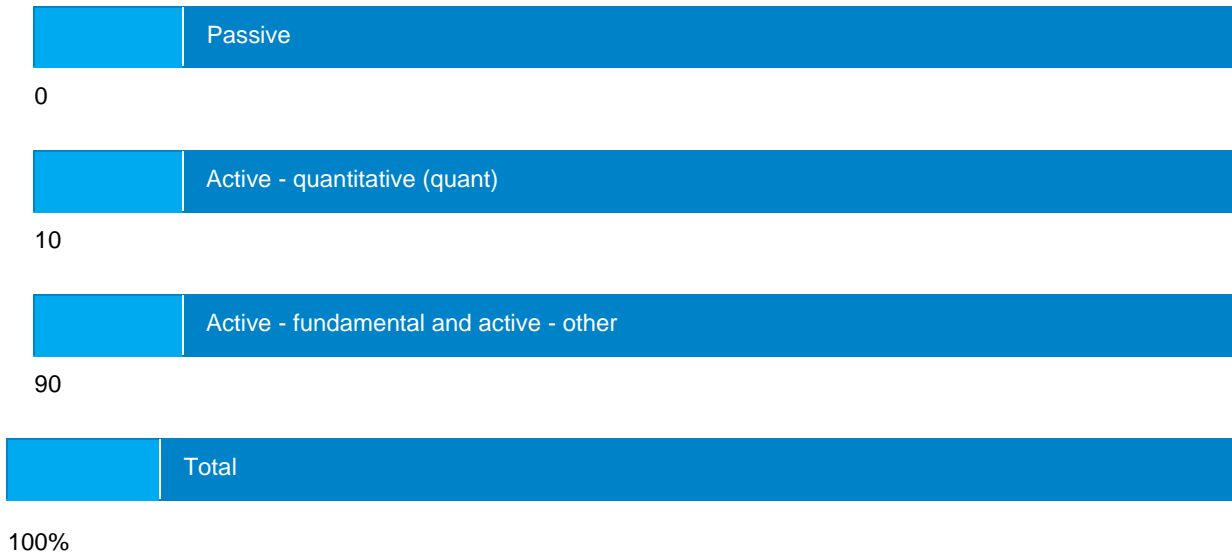

Since its création in 2008, Mandarinne Gestion created funds in line with one major principle: to be in line with the real economy. The overall strategy was to create different expertises (value, growth, ESG, solidarity, asset allocations) in order to embrace all aspects of the real economy.

Mandarinne Gestion has developed what we call "ESG Integration" for all of its funds. That is to say that ESG information is provided in the front office tool to every portfolio manager, both at portfolio and company level. A good understanding of controversies that may impact companies are outlined.

Overall ESG factors are taken into account for the majority of the AUMs at Mandarinne Gestion.

In addition to ESG integration, Mandarinne Gestion has now 4 SRI-labelled funds. They account for one third of AUM.

Mandarine Gestion has implemented an overall ESG policy for the company and its activities. In addition to our SRI funds, we have developed an ESG integration approach for all our funds, including the non-SRI ones. The RI management process has been implemented around an in-house tool, "ESG-View". This tool, dedicated to ESG data, is under the responsibility of the Head of SRI management. His role is to fill the tool with ESG data, coming from his own research or external research, and trying to cover the whole investment universe of our funds. This information is provided through the ESG-View tool to the front-office tool of all the fund managers who have then access to all ESG data on their portfolio's holdings. The fund managers' responsibility is to have knowledge of this information and to be aware of ESG stakes, but without any duty or constraint, except for our SRI fund which has specific RI policy and process, and active RI constraints.

The RI management use external tool to stay informed of any controversy that concerns a listed equity invested on a fund. The ratings are, as much as possible, updated continuously thanks to new reports or meetings with the companies.

We also publish ESG reporting for each fund on a quarterly basis, that includes extensive details on the ESG profile of the fund. Every two months, we also have a dedicated presentation where we present the updates of the ESG reportings, and a chosen sectorial or thematic presentation on ESG issues.
